ORDINANCE 109951

AN ORDINANCE creating a new Chapter 10.03 in the Seattle Municipal Code, and establishing fees for permits, inspections, examinations, and other administrative services, as required in Title 10 of the Seattle Municipal Code.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. A new Chapter 10.03 is hereby added to the Seattle Municipal Code to establish Health Code Fees. It establishes fees subject to the provisions of the Health Code.

Section 10.03.010 Fees for administration of the Health Code shall be:

- Replacement of lost or destroyed permit\$ 2.00
- Permit Transfer\$ 2.00
- Payment of permit fee with dishonored check\$ 10.00
- Late fee if delinquent by noOne quarter (1/4) of the
more than ten (10) days applicable permit fee
- Inspections requests byCost to the Department of
permittee or person in charge of performing the service
of regulated activity, if outside
regular Department working hours
- Furnishing special services orCost to the Department of
materials, requested by the performing the service or
public, if not ordinarily furnishing the materials
provided by the Department

Section 10.03.020 Fumigator & Exterminator Permit and Examination Fees.

Fees for permits, examinations and inspections under this Chapter shall be paid prior to permit issuance, examination or inspection as follows:

- Master Fumigator\$100.00
- Master Exterminator\$100.00
- Master Fumigator and Master Exterminator Permit\$100.00
(If Held by the Same Individual)
- Fumigator\$ 10.00
- Exterminator\$ 10.00
- Fumigator and Exterminator Permit\$ 10.00
(If Held by the Same Individual)
- Apprentice\$ 10.00

Section...2.. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
