6 **BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

7 Section 1. Payment of the sum of \$22,323,761.22 on Summit mechanical warrants
8 numbered 4002293765 – 4002296516 plus manual or cancellation issues for claims, E-
9 Payables of \$62,741.46 on Summit 9000014723 – 9000014785 and Electronic Financial
10 Transactions (EFT) in the amount of \$42,857,684.51 are presented for ratification by the City
11 Council per Chapter RCW 42.24.180.

12 Section 2. Payment of the sum of \$37,874,311.13 on City General Salary Fund
13 mechanical warrants numbered 51197444 – 51198168 plus manual warrants, agencies
14 warrants, and direct deposits numbered 60001 – 71368 representing Gross Payrolls for
15 payroll ending date Jan 28, 2014 as detailed in the Payroll Summary Report for claims
16 against the City which were audited by the Auditing Committee and reported by said
17 committee to the City Council Feb 6, 2014 consistent with appropriations heretofore made for
18 such purpose from the appropriate Funds, is hereby approved.


19 Section 3. That any act consistent with the authority and prior to the effective date of
20 this ordinance is hereby ratified and confirmed.

21 Section 4. This ordinance shall take effect and be in force 30 days after its approval
22 by the Mayor, but if not approved and returned by the Mayor within ten days after
23 presentation, it shall take effect as provided by Seattle Municipal Code Section 1.04.020.




